## PINE BARREN MODELERS RC CLUB A POST 9503 PARTNER ORGANIZATION



Pine Barren Modelers RC Club (PBM) has been busy for the past couple of months. Besides flying RC planes, the PBM is now involved with RC car racing. Our club has acquired a vacant warehouse in Forked River and we have been busy getting it in shape to house up

to three indoor race tracks.

The facility will be called W. Holm Indoor RC Park hosted by the Pine Barren Modelers RC Club. The facility is located at 510 Route 9 South, Forked River, NJ and is located right off of Old Shore Road and Route 9.

As you can from the picture, we are close to finishing the first of three tracks. This track is in the front room of the warehouse and will be racing Mini Z cars for the most part. We're utilizing what is called RCP track which is 30 cm squares and can be configured for any track layout. Along with the RCP track, we will be using an electronic lap counting system so that we can run actual races.

It will not be necessary to join the Pine Barren Modelers RC Club to participate in the scheduled races however, joining our club will provide the benefit of being able to use the facility at any time at no additional fee. With regards to the flying site at Berkeley Township municipal facility, it has been a slow process to complete. Our club has been working with the township administrator, council members and the mayor to have this completed by the spring of 2020. Although, the runway and the parking lot has been completed, there still needs to be some work needed to fully utilize this flying field.

Additional work needs to be completed to the runway area such as trees removed or cut back, the infield being properly graded and leveled. Once this has been completed, we can then make this our permanent flying field.

The sign which has been graciously donated by the VFW has been completed and is temporarily installed at the entrance of the flying field. We are working with the township on moving out to the main entrance of the municipal facility on Pinewald Keswick Road.

## FROM THE POST SURGEON

If you need support for a specific mental health problem—or if you're having problems sleeping, controlling your anger, or readjusting to civilian life—the VA can help.

Over 1.7 million Veterans received mental health services at VA last year. Services range from peer support with other Veterans to counseling, therapy, medication, or a combination of these options. The goal is to help you take charge of your treatment and live a full and meaningful life.

### How do I schedule my first appointment?

If you're already using VA medical services, ask your primary care provider to help you make an appointment with a VA mental health provider.

If you're not already using VA medical services, contact your nearest VA medical center or Vet Center to talk about your needs.

### What if I'm not sure what kind of help I need?

You can call 877-222-8387 to find the right resources for your needs. If you have hearing loss, call TTY: 800-877-8339, Monday through Friday, 8:00 a.m. to 8:00 p.m. ET.

The VA telemental health program: You can connect with a VA mental health provider through a computer or mobile device in your home or at your nearest VA health facility. If you're enrolled in VA health care, ask any of your providers to help connect you with our telemental health program.

### Can I speak to a fellow Veteran who's been through this before?

Yes. The BeThere peer assistance program, in partnership with Military OneSource, offers support to service members (including National Guard soldiers and Reservists), their families, and transitioning Veterans up to 365 days after separation or retirement. Through this program, you can talk privately with peer coaches who are Veterans, service members, or military spouses.

To talk with a peer coach, call Military OneSource's free, confidential peer support services at 800-342-9647. This service is available 24 hours a day, 365 days a year.

### What other options do I have?

If you're a combat Veteran, you can visit one of our Vet Centers to get free individual and group counseling for you and your family. You can access these services even if you're not enrolled in VA health care and aren't receiving disability compensation.

### Vet Centers offer services such as:

Military sexual trauma (MST) counseling  
Readjustment counseling  
Bereavement (grief) counseling  
Employment counseling  
Substance abuse assessment and referral

You can also call 877-927-8387 to talk with a fellow combat Veteran about your experiences, 24 hours a day, 7 days a week, 365 days a year.

If you'd like to connect with other Veterans, families, and local services, you can visit the Make the Connection website. This site connects millions of Veterans, and their family members and friends, to local VA and community mental health resources. Visit the site to access these referral resources and hear Veteran testimonials of strength and recovery.

## SILVER STAR

Two Air Force parascuemen have received the nation's third highest award for valor for separate missions in Afghanistan nearly one year apart that saved the lives of their fellow troops. Tech. Sgt. Gavin Fisher, 350th Special Warfare Training Squadron, Joint Base San Antonio-Lackland, Texas, and Staff Sgt. Daniel Swensen, 58th Rescue Squadron of Nellis Air Force Base, Nevada, each received a Silver Star during a ceremony at Nellis on Friday. Fisher was also awarded a Purple Heart in recognition of combat wounds.

Fisher was a part of the Ghazni province offensive that began against Taliban fighters in eastern Afghanistan on Aug. 11, 2018, according to the Air Force. Swensen distinguished himself on Sept. 13, 2019 in Farah province, on the opposite side of the country, prosecuting a ground offensive against the Taliban.

While their missions were distinct, Fisher and Swensen faced similar peril: The two men engaged in heavy fire for two days and sustained battle wounds, but managed to fend off the enemy while treating other casualties on the battlefield.

Together, they saved over 40 lives and took out more than 100 enemy fighters, the Air Force said in a release.

"For some of you, you may ask yourself how these two individuals in the face of such adversity performed so admirably," Lt. Col. Douglas Holliday, commander of the 58th Rescue Squadron, said in a statement. "Airmen like Dan and Gavin are part of a profession that dedicates their lives to a motto 'That Others May Live.'"

"A foundation of that motto is a pledge they made going through selection and years of arduous training. In the face of adversity, when Americans and our allies' lives are on the line, under no circumstance will you quit on them. Never quit," Holliday added.

Fisher was part of a team working to thwart Taliban efforts to gain territory following a surprise attack on the city of Ghazni. He was assigned to the 83rd Expeditionary Rescue Squadron at the time.

He was operating as the rear gunner for the lead convoy vehicle when the Taliban hit the convoy's position repeatedly with rocket-propelled grenades and machine-gun fire.

During the chaos of the fight, Fisher was hit by shrapnel, but continued to fight and save others despite his own wounds, the Air Force said. He ran back and forth to render medical aid -- including blood transfusions for two critically wounded soldiers -- and oversee multiple helicopter evacuations before returning to the convoy to fire on the enemy.

"Wounded and refusing to leave with the patients, Fisher was involved in a second ambush," the release said. "Placing others' lives before his, he treated five additional critically injured partner force casualties and requested a second medical evacuation."

Again running through a barrage of gunfire, Fisher then treated another five casualties.

As the clearing operation went on, an RPG struck Fisher's vehicle, immobilizing him. After first returning fire and directing his team to safety, Fisher finally had to seek medical care for himself.

"Getting this medal is important, because it lets people know the war is still going on, and valiant efforts by men and women are still going forth," Fisher said. "People are still out there dying and fighting for each other, and it needs to be recognized."

Swensen was attached to an Army Special Forces unit working to expel Taliban fighters from the Anar Darah District Center and police headquarters, the Air Force said. The operation included a helicopter assault from above, while Swensen, part of Operational Detachment-Alpha 1215, led his teammates through a compound.

While the team took steady bombardment, a grenade hit a wall near their position, wounding Swensen and five troops, the release said.

The blast separated the troops from the remaining support team. Cordoned off and physically backed into a corner, Swensen "fired back at the Taliban and directed his partner forces to safety," the release said. Swensen then ran through "intense enemy fire to rescue a fallen soldier incapacitated by his injuries" and treated him despite the gunfire spraying around him, it said.

Swensen rounded up troops in need of medical transport, and even carried one soldier on his shoulders to vacate the gunfire zone; they covered about a about a half-mile of ground so the wounded could be safely evacuated.

After moving the hurt as quickly as he could, Swensen returned to the city compound "to retrieve four additional casualties," the Air Force said. Swensen waited until those forces were accounted for before he was treated for his own injuries.

"It's weird to receive so much attention for something that I feel anyone else would've done on the battlefield that night," Swensen said. "I'm honored my peers think I deserve this medal."

Pacific Air Forces commander Gen Charles 'CQ' Brown lauded Swensen and Fisher during the ceremony, noting the two airmen have joined an elite group of exemplary warfighters.

"We can become so absorbed by the tales and the characters and their abilities that we can lose sight of our real-life heroes -- heroes like Tech. Sgt. Gavin Fisher and Staff Sgt. Daniel Swensen," Brown said.

"Only 1 percent of our service men and women, representing 1 percent of the population have received this Silver Star. So, these gentlemen are in a very exclusive club."

## **CELEBRITY VETERAN: TECHNICAL SERGEANT JOE LOUIS, USA**

**Joseph Louis Barrow** was an American professional boxer who competed from 1934 to 1951. He reigned as the world heavyweight champion from 1937 to 1949, and is considered to be one of the greatest heavyweight boxers of all time. Nicknamed the “Brown Bomber”, Louis’ championship reign lasted 140 consecutive months, during which he participated in 26 championship fights.

Born in rural Chambers County, Alabama on May 13, 1914, Louis was the seventh of eight children of Munroe Barrow and Lillie Barrow. Louis spent the first dozen years growing up in rural Alabama. He suffered from a speech impediment and spoke very little until about the age of six.

Louis fought a charity bout for the Navy Relief Society on January 9, 1942, which raised \$47,000 for the fund. The next day, he volunteered to enlist as a private in the United States Army at Camp Upton, Long Island. For basic training, Louis was assigned to a segregated cavalry unit based in Fort Riley, Kansas.

Realizing Louis’s potential for raising esprit de corps among the troops, the Army placed him in its Special Services Division rather than sending him into combat. Louis went on a celebrity tour with other notables, including fellow boxer Sugar Ray Robinson. He staged 96 boxing exhibitions before two million soldiers.

In addition to his travels, Louis was the focus of a media recruitment campaign encouraging African-American men to enlist in the Armed Services, despite the military’s racial segregation. When he was asked about his decision to enter the racially segregated U.S. Army, he said: “Lots of things wrong with America, but Hitler ain’t going to fix them.”

Louis was eventually promoted to the rank of technical sergeant on April 9, 1945. On September 23 of the same year, he was awarded the Legion of Merit (a military decoration rarely awarded to enlisted soldiers) for “incalculable contribution to the general morale.” Receipt of the honor qualified him for immediate release from military service on October 1, 1945.

Louis died of cardiac arrest in Desert Springs Hospital near Las Vegas on April 12, 1981. Ronald Reagan waived the eligibility rules for burial at Arlington National Cemetery and Louis was buried there with full military honors on April 21, 1981.

# FEDS CRACK DOWN ON BOGUS VETERAN CHARITIES

You may have seen them standing outside convenience stores, those guys dressed in camo that vaguely resembles a uniform. They have signs saying claiming they are charities that help veterans. Are they legit? Well, not all of them are.

The Federal Trade Commission, along with law enforcement officials and regulators from offices in every state announced more than 100 actions and a consumer education initiative in “Operation Donate with Honor”. The action was a crackdown on fraudulent charities that con consumers by falsely promising their donations will help veterans and service members.

## Two Charities Face Federal Charges

### Help the Vets

Neil G. “Paul” Paulson, Sr. and Help the Vets, Inc., (HTV) will be banned from soliciting charitable contributions under settlements with the FTC and the states of Florida, California, Maryland, Minnesota, Ohio and Oregon, for falsely promising donors their contributions would help wounded and disabled veterans.

The defendants were charged with violating federal and state laws related to their actions. According to the FTC’s complaint, HTV did not help disabled veterans, and 95 percent of every donation was spent on fundraising, administrative expenses, and Paulson’s salary and benefits.

Operating under names such as American Disabled Veterans Foundation, Military Families of America, Veterans Emergency Blood Bank, Vets Fighting Breast Cancer, and Veterans Fighting Breast Cancer, HTV falsely claimed to fund medical care, a suicide prevention program, retreats for veterans recuperating from stress, and veterans fighting breast cancer.

In addition to the ban on soliciting charitable contributions, the proposed settlement order bans Paulson from charity management and oversight of charitable assets. To ensure that donors to HTV are not victimized again, HTV and Paulson must destroy all donor lists and notify their fundraisers to do so.

The order imposes a judgment of \$20.4 million, which represents consumers’ donations from 2014 through 2017, when HTV stopped operating. The judgment will be partially suspended when the defendants have paid a charitable contribution to one or more legitimate veterans charities recommended by the states and approved by the court. Paulson must pay \$1.75 million – more than double what he was paid by HTV – and HTV must pay all of its remaining funds, \$72,000.

### Veterans of America

The FTC charged Travis Deloy Peterson with using fake veterans’ charities and illegal robocalls to get people to donate cars, boats and other things of value, which he then sold for his own benefit.

The scheme used various names, including Veterans of America, Vehicles for Veterans LLC, Saving Our Soldiers, Donate Your Car, Donate That Car LLC, Act of Valor, and Medal of Honor. Peterson allegedly made millions of robocalls asking people to donate automobiles, watercraft, real estate, and timeshares, falsely claiming that donations would go to veterans charities and were tax deductible.

In fact, none of the names used in the robocalls is a real charity with tax exempt status. Peterson is charged with violating the FTC Act and the FTC’s Telemarketing Sales Rule.

At the FTC’s request, a federal court issued a temporary restraining order prohibiting Peterson from making unlawful robocalls or engaging in misrepresentations about charitable donations while the FTC’s enforcement action is proceeding.

## State Enforcement Actions

States also identified and charged several charities and fundraisers who sought donations online and via telemarketing, direct mail, door-to-door contacts, and at retail stores. These groups falsely promised to help homeless and disabled veterans, to provide veterans with employment counseling, mental health counseling or other assistance, and to send care packages to deployed service members.

## 2019-2020 State Commanders Project

This year's Commanders Project will focus on 3 issues that will improve the lives and wellbeing of New Jersey's veterans along with honoring our own forgotten brothers and sisters. Your donations will be used for the following programs:

**MENTAL HEALTH / SUICIDE AWARENESS 40%:** It is inconceivable that 22 veterans a day feel so alone and desperate that they believe committing suicide is the answer to their problems. This is not a generational or gender issue, 58.1% of veteran suicide victims are over the age of 55 and women veterans are 1.8 times more likely to commit suicide than non-veterans. I believe it is a priority for us to reduce a veteran's risk for suicide before they reach a crisis point and support those in crisis. We can't combat this alone and we must build networks of support, communication, and care across the communities where veterans live and work. To accomplish this goal, 40% of the funds raised will be used to support:

- Department wide participation of the 4<sup>th</sup> annual VFW Campaign to Change Direction on September 14, 2019, a national day of service and action to change the dialogue on mental health for veterans and their communities.
- Grants to Districts, Posts, and partnering organizations to implement support groups, awareness campaigns, mentor programs, etc., on the local level.

**CONTINUED FUNDING OF THE DEPARTMENT VETERANS ASSISTANCE PROGRAM 50%:** Started by Commander Sarmiento, this important program lends a hand up to veterans and troops in need who do not reside in the vicinity of a VFW Post. I believe this program furthers our goal of assisting veterans before they reach a crisis point by keeping a roof over their head and food on the table.

**MISSING IN AMERICA PROJECT 5%:** Their mission is to locate, identify and inter the unclaimed remains of American veterans. Locally the project is coordinated by Vietnam Veterans of America Chapter 12 in Oakhurst.

**GUIDING LIGHTHOUSE 5%:** A transitional homeless veteran facility open to female veterans. The 24 month program includes mental health counseling, financial coaching and job skills training under the supervision of a case manager. The facility is located in Jackson N.J.
